INTRODUCTION

The Proficiency in Short-Term Reinsurance Practice and Claims Management Course (PSTRP) is a comprehensive examinable training program which combines all key reinsurance functions of underwriting, program design, accounting, reinsurance portfolio placement and claims management. It is designed to equip the trainees with technical reinsurance knowledge and skills that would enable them carry out reinsurance underwriting, accounting and claims tasks competently.

COURSE OBJECTIVES

- Demonstrate an understanding of the reinsurance business and how it is transacted
- Comprehension of the process of reinsurance underwriting and claims management
- Practical application of the principles of reinsurance in processing and finalizing reinsurance underwriting and claims
- Design and prepare reinsurance covernotes for different types of reinsurance transactions.
- Process and compute reinsurance related data within the established standards and framework.

COURSE DURATION

This is a ten (10) days intensive training program with morning and afternoon sessions lasting 3 hours each.

TARGET GROUP

The Proficiency in Short-Term Reinsurance Practice and Claims Management Course is intended for all the employees deployed in the following departments of an Insurance and or Reinsurance Organisation; Direct Underwriting; Claims; Reinsurance Underwriting, and Reinsurance Accounting.

ENTRY REQUIREMENTS

The trainee must be an employee working in any of the departments listed under the "Target Group" and holds the following qualifications:- a minimum O-Level Certificate of Education or equivalent qualification; or a minimum of two years working experience in reinsurance and related work.

ASSESSMENT & EXAMINATION

The Proficiency in Reinsurance Practice will be assessed through Continuous Assessment Tests (CATs) and a Final Exam administered by the College of Insurance Kenya in conjunction with the ZEP-RE Academy.

LOGISTICS

Participants must have a high internet speed connection and a digital device – preferably a laptop or tablet/iPad. All the training sessions will be via ZOOM, and participants are required to download this application in advance upon admission to the webinar. The CATs and Final Exam will also be online.
